**THE TOWN OF BECKET'S  
COMMUNITY CHOICE POWER SUPPLY PROGRAM  
CONSUMER NOTIFICATION**

The Town of Becket is pleased to announce that **Dynergy Energy Services** (“Dynergy”) has been selected as the supplier for its Community Choice Power Supply Program (“Program”). Dynergy will provide electric power supply for all consumers currently on Basic Service in Becket. This notice is intended to tell you about this Program for electric power supply. In accordance with state law, it also informs you of your rights and options if you choose not to participate in the Program.

**YOU WILL NOT NOTICE ANY CHANGE IN YOUR ELECTRICITY SERVICE.** The only difference you will see is that Dynergy will be printed under the “Supplier Services” section of your monthly bill. You will continue to receive one bill from Eversource. You will continue to send your payments to Eversource for processing. Eversource will continue to respond to emergencies, read meters and maintain the distribution and transmission lines. Reliability and quality of service will remain the same. Furthermore, you will continue to have all existing consumer rights and protections.

**IF YOU ARE A BASIC SERVICE CONSUMER WHO HAS BEEN MAILED A NOTIFICATION** you do not need to take any action to participate. You will be AUTOMATICALLY enrolled and start benefiting from the aggregation rate beginning on the day of the month in January 2021 that your meter is read. This date varies by service area. Your meter reading date is shown on your bill.

**WATCH YOUR EVERSOURCE BILL FOR FURTHER NOTIFICATION** of the Program.

- Your January 2021 bill will state that you are being switched to Becket's Program.
- Your February 2021 bill will show Becket's supplier and aggregation rate under “Supplier Services”.

**IF YOU DO NOT WISH TO PARTICIPATE** you must OPT-OUT by signing and returning the Opt-Out Reply Card included with the mailed notification **OR** visit [colonialpowergroup.com/becket](http://colonialpowergroup.com/becket), click the OPT-OUT button and follow the instructions specified **OR** call Dynergy at (866) 220-5696.

**IF YOU WISH TO JOIN THIS PROGRAM** you may OPT-IN at [colonialpowergroup.com/becket](http://colonialpowergroup.com/becket) **OR** call Dynergy at (866) 220-5696 and ask to be enrolled. If you are currently contracted with your own Competitive Supplier, you should confirm with them that you will not incur any early termination fees or penalties for leaving their supply.

**TO CHOOSE A PRODUCT WITH A HIGHER PERCENTAGE OF RENEWABLE ENERGY** visit [colonialpowergroup.com/becket](http://colonialpowergroup.com/becket) or you may call Dynergy at (866) 220-5696 and ask to be enrolled in Becket's Optional Green Product. Becket's Optional Green Product provides 25% MA Class I Renewable Energy Certificates (RECs) above the state's then-current requirement for these renewables [43% in 2021; 45% in 2022; 47% in 2023]. This product is being offered at \$0.10313 per kWh for 36 months (January 2021 to January 2024).

Basic Service rates change twice a year or more, depending on rate class. As a result, the aggregation rate may not always be lower than the Basic Service rate. The goal of the aggregation is to deliver savings over the life of the Program against Eversource Basic Service. However, such savings and future savings cannot be guaranteed.
