**THE TOWN OF WARWICK'S  
COMMUNITY CHOICE POWER SUPPLY PROGRAM  
CONSUMER NOTIFICATION**

The Town of Warwick is pleased to announce that **Dynegy Energy Services** (“Dynegy”) has been selected as the supplier for its Community Choice Power Supply Program (“Program”). Dynegy will provide electric power supply for all consumers currently on Basic Service in Warwick. This notice is intended to tell you about this Program for electric power supply. In accordance with state law, it also informs you of your rights and options if you choose not to participate in the Program.

**YOU WILL NOT NOTICE ANY CHANGE IN YOUR ELECTRICITY SERVICE.** The only difference you will see is that Dynegy will be printed under the “Supply Services” section of your monthly bill. You will continue to receive one bill from National Grid. You will continue to send your payments to National Grid for processing. National Grid will continue to respond to emergencies, read meters and maintain the distribution and transmission lines. Reliability and quality of service will remain the same. Furthermore, you will continue to have all existing consumer rights and protections.

**TO CHOOSE A PRODUCT WITH 100% NEW ENGLAND RENEWABLE ENERGY** you may call Dynegy at (866) 220-5696 and ask to be enrolled in Warwick’s Optional Green Product. Warwick’s Optional Green Product provides 100% MA Class I Renewable Energy Certificates (RECs). This product is being offered at \$0.12466 per kWh for the first 5 months (August 2020 to December 2020), then changes and is being offered at \$0.13032 per kWh for the remaining 36 months (January 2021 to January 2024).

**IF YOU ARE A BASIC SERVICE CONSUMER WHO HAS BEEN MAILED A NOTIFICATION** you do not need to take any action to participate. You will be AUTOMATICALLY enrolled and start benefiting from the aggregation rate beginning on the day of the month in August 2020 that your meter is read. This date varies by service area. Your meter reading date is shown on your bill.

**WATCH YOUR NATIONAL GRID BILL FOR FURTHER NOTIFICATION** of the Program.

- Your August 2020 bill will state that you are being switched to Warwick's Program.
- Your September 2020 bill will show Warwick's supplier and aggregation rate under "Supply Services".

**IF YOU DO NOT WISH TO PARTICIPATE** you must OPT-OUT by signing and returning the Opt-Out Reply Card included with the mailed notification **OR** visit [colonialpowergroup.com/warwick](http://colonialpowergroup.com/warwick), click the OPT-OUT button and follow the instructions specified **OR** call Dynegey at (866) 220-5696.

**IF YOU WISH TO JOIN THIS PROGRAM** you may OPT-IN at [colonialpowergroup.com/warwick](http://colonialpowergroup.com/warwick) **OR** call Dynegey at (866) 220-5696 and ask to be enrolled. If you are currently contracted with your own Competitive Supplier, you should confirm with them that you will not incur any early termination fees or penalties for leaving their supply.
