**THE TOWN OF WENDELL'S  
COMMUNITY CHOICE POWER SUPPLY PROGRAM  
CONSUMER NOTIFICATION**

The Town of Wendell is pleased to announce that **Dynergy Energy Services** (“Dynergy”) has been selected as the supplier for its Community Choice Power Supply Program (“Program”). Dynergy will provide electric power supply for all consumers participating in Wendell’s Program. This Program supports renewable energy as 100% of the power supply is offset with National Wind Renewable Energy Certificates. This notice is intended to tell you about this Program for electric power supply. In accordance with state law, it also informs you of your rights and options if you choose not to participate in the Program.

**YOU WILL NOT NOTICE ANY CHANGE IN YOUR ELECTRICITY SERVICE.** You will see Dynergy printed under the “Supply Services” section of your monthly bill. You will continue to receive one bill from National Grid. You will continue to send your payments to National Grid for processing. National Grid will continue to respond to emergencies, read meters and maintain the distribution and transmission lines. Reliability and quality of service will remain the same. Furthermore, you will continue to have all existing consumer rights and protections.

**PARTICIPATING CONSUMERS** will start benefiting from the aggregation rate beginning on the day of the month in January 2020 that their meter is read. This date varies by service area. Your meter reading date is shown on your bill.

**IF YOU ARE A BASIC SERVICE CONSUMER WHO HAS BEEN MAILED A NOTIFICATION** you do not need to take any action to participate. You will automatically be enrolled. If you do not wish to participate, please follow the instructions specified.

Basic Service rates change twice a year or more, depending on rate class. As a result, the aggregation rate may not always be lower than the Basic Service rate. The goal of the aggregation is to deliver savings over the life of the Program against National Grid Basic Service. However, such savings and future savings cannot be guaranteed.
